1 OVERVIEW

1.1 STUDY AIMS

Leveraging a long-term wearable (Fitbit Charge 6), the aims of the Fitbit study are to:

- 1) Evaluate technology acceptance in the oldest old.
- 2) Evaluate the relationship between wearable data (heart rate, physical activity, sleep) and cognitive and physical decline and dementia, and how they are impacted by biomarker levels.
- 3) Evaluate the relationship between wearable data (heart rate, physical activity, sleep) and major adverse cardiac events, including all-cause hospitalization; hospitalization for acute myocardial infarction, stroke, or heart failure; all-cause mortality; and cardiovascular mortality.

1.2 BACKGROUND AND RATIONALE

In recent years, there has been a substantial uptake of digital technology, including smartphones and wearables among adults in the United States. Wrist-worn trackers generate large amounts of real-time data, and clinicians are increasingly presented with these data in practice. However, the interpretation of these data (i.e., heart rate, physical activity, and sleep) has been limited by a lack of longitudinal data in large diverse cohorts, particularly among older adults. This protocol will provide some of the first long-term data on heart rate, physical activity, and sleep among older adults.

To fill these gaps, we will provide interested, eligible, and consented participants in ARIC with a Fitbit Charge 6 at Visit 11 (Day 2 if completing over 2 days). The Fitbit Charge 6 is for the participants to keep for <u>their use</u>. Participants will also receive ongoing tech support and monetary compensation. We will collect wearable data from the participants (and compensate them) for as long as they are willing to wear the Fitbit Charge 6, for up to four years. The Fitbit Charge 6 was chosen for its long battery life of seven days, functionality, compatibility with both iOS and Android devices, and early evidence of measurement validity and ease of use among older adults.

1.3 KEY MEASURES

Up to 4 years (or as long as the participant is willing to wear the Fitbit) of data collection on heart rate, physical activity, and sleep.

1.4 STUDY PARTICIPANTS

The Fitbit study protocol will be offered to all participants returning for the Visit 11 examination who own a smartphone capable of running software compatible with a Fitbit Charge 6 (iPhone requires iOS 15.0 or later; Android requires Android 9 or later).

.

If completing Visit 11 over 2 days, participants will be asked if they own a smartphone on Day 1. If they do own a smartphone and are interested in participating in the Fitbit study, they will be asked to bring their smartphone to Day 2 of the Visit.

Exclusions

- The participant does not own a smartphone.
- The participant owns a smartphone but it is not capable of running software compatible with a Fitbit Charge 6 (iPhone requires iOS 15.0 or later; Android requires Android 9 or later).
- The participant has an implantable medical device such as a pacemaker or cardiac defibrillator. Consumer electronic devices, like the Fitbit, may create magnetic interference with implanted medical devices.

* Participants that already own a Fitbit Watch will be <u>strongly encouraged</u> to upgrade to the Fitbit Charge 6 through this study. However, if they do not wish to upgrade to the Fitbit Charge 6 but still want to participate in the Fitbit study, they can be enrolled using their own Fitbit Watch. If a participant owns an Apple Watch or another type of wearable, they will be offered the Fitbit Charge 6. However, these individuals with another type of wearable that don't want the Fitbit Charge 6 cannot be enrolled in the Fitbit study.

Participant Reimbursement

Participants will be reimbursed \$10 a month for every month they provide Fitbit data (i.e., wear the Fitbit Watch and sync with the Fitbit smartphone application). Participants should be told that we expect them to wear the Fitbit Watch and provide data 80% of days each month (~24 out of 30 days). However, to receive the \$10 a month they only have to wear the Fitbit Watch and provide data for 50% of days each month (~15 out of 30 days). The JHU Wearable team and/or field center staff discretion can be used to determine whether participants made a reasonable effort to meet these expectations for reimbursement. Participants will be sent the appropriate reimbursement every 6 months.

1.5 EQUIPMENT, MATERIALS, AND SUPPLIES

1.6 CONSENT PROCESS

Consent for the Fitbit protocol is included in the Visit 11 consent. Consented participants will be assessed for eligibility and interest, which is documented in the Fitbit Initialization Form (FBI).

1.7 OVERVIEW OF STUDY PROCEDURES

Participants with a smartphone attending the Visit 11 exam will be invited to participate in the proposed project, which includes wearing the Fitbit Charge 6 and syncing with the Fitbit smartphone application.

Installing and creating a Fitbit account, setting up the Fitbit Watch and smartphone app for participant use, teaching the participants how to use the devices, and registering the participant in Fitabase will take approximately 40 minutes during the visit. Field Center staff will monitor participant adherence on a continuous basis throughout the study via Fitabase.

2 DETAILED STUDY PROCEDURES

The study procedures included below assume the participant is completing the visit over two days. If the participant is completing the visit in one day, the steps in Section 2.3 should be completed the day before the visit. A reminder for the participant to bring their smartphone is included in the visit appointment letter.

2.1 DAY 1 VISIT

Ask participants if they own a smartphone; if yes, introduce them to the Fitbit Study that will be occurring on Day 2 of the exam.

If the participant's smartphone software is not up-to-date, you will need to update the phone's software in the Settings app in order to download the Fitbit app (on Day 2). This will likely be a rare occurrence, but staff should check the software version of the participant's phone at the beginning of the visit on Day 1. This way, if the software needs to be updated it can be done before Day 2.

• iPhone requires iOS 15.0 or later; Android requires Android 9 or later

2.2 SCHEDULING DAY 2 VISIT

Ask participants if they own a smartphone; if yes, remind them to bring their smartphone to the Visit. Also, ask participants to bring their Apple ID email address and Apple ID password (if they own an iPhone). The protocol can still be completed without this information, as explained below; however, the visit will go faster if they have it on-hand.

2.3 DAY BEFORE DAY 2 VISIT

Update the software of the Fitbit Watch that will be given to the participant the next day. You can use a field center smartphone or tablet that has the Fitbit app to do this. This will decrease the amount of time needed to complete the Fitbit protocol during the Day 2 Visit. Another option is to conduct this process during the Day 2 Visit, before the Fitbit onboarding is conducted / while the participant is engaged in other study procedures.

- 1. Open the Fitbit app, on the field center smartphone/tablet, and on the "Today" screen, go to the "Device Settings" by selecting the icon in the upper left corner
- 2. Select "Add Device"
- On the screen, "What are you setting up?"Select "Charge 6"
- 4. Select "Set Up"
- 5. Scroll to the bottom of the page and select "I Agree" to connect the Charge 6 to the Fitbit app

- 6. On the screen, "Let it charge"o Select "Next"
- 7. The phone will search for the Fitbit Charge 6 (make sure the Watch is plugged in to charge, as this is required to "find" the watch regardless of its battery percentage)
- 8. Once the Phone "finds" the Watch, a 4-digit code will appear on the Watch
 o Enter the 4-digit code into the phone



- 9. A message will pop up on the phone: "Bluetooth Pairing Request: Charge 6 would like to pair with your phone"
 - o Select "Pair"
- 10. A message will pop up on the phone: "Allow Charge 6 to Receive Your Notifications: When connected, all notifications you receive on your phone will also be sent to the Charge 6 and may be shown on its display"
 - o Select "Allow"
- 11. Select "Not Now" when asked about Protecting Your New Device
- 12. On the screen, "Update your Charge 6"
 - Select "Update Now"
 - Wait for the software to be downloaded and installed on the Watch
 - Once the app says "Charge 6 is updated", select "Continue"

- 13. On the screen, "Set up irregular rhythm notifications"Select "Skip"
- 14. On the screen, "Try it on" o Select "Next"
- 15. On the screen, "Press button to wake"Select "Next"
- 16. On the screen, "Swipe to navigate"o Select "Next"
- 17. On the screen, "Swipe to go back"Select "Next"
- 18. On the screen, "Tap 3x to zoom in"o Select "Next"
- 19. On the screen, "Wear & care tips"o Select "Next"
- 20. On the screen, "All Set!" o Select "Done"
- 21. Option to buy Premium will come up on the phone o "X" out
- 22. Go back into the "Device Settings" in the Fitbit app by selecting the icon in the upper left corner
- 23. Select "Charge 6"



- 24. Scroll down and select "Remove Charge 6"
- 25. A notification will pop up, confirm that you want to "Remove This Charge 6" from the field center smartphone or tablet
- 26. Remove the Fitbit Charge 6 Watch from the Settings app on the field center smartphone or tablet after completing the updating process
 - Open up the smartphone/tablet Settings app
 - Select "Bluetooth"
 - Select "Charge 6"
 - Select "Forget This Device"

2.4 DAY 2 VISIT

After ensuring the participant does not have a pacemaker or other implanted medical device (see Participant Snapshot), complete Section A of the Fitbit Initialization Form (FBI) to determine if the participant meets the other exclusion criteria. Complete Section B and C after the device has been initialized and the Fitbit and Gmail accounts have been created. Note, the Fitbit serial number should be scanned into the FBI form in order to avoid transcription error.

You will be completing the following steps on the participant's phone for them. You should use hand sanitizer before and after completing the following steps.

Fitbit Charge 6 – Install and Create an Account

This section describes how to set up the Fitbit Charge 6, including: charging the Fitbit, downloading the Fitbit app onto the participant's smartphone (iOS or Android), syncing the Fitbit with the app, and creating an account.

Downloading the Fitbit App

- Steps 4-7 of this section should be completed even if the participant already has the Fitbit app on their phone
- 1. Charge the Watch during the initial steps of the setup process.
- 2. Connect the participant's smartphone to the Field Center's Wi-Fi to speed up app download.
- 3. Download the Fitbit mobile app onto the participant's smartphone. For iPhones, download the app from the iOS store. For Android phones, download the app from Google Play.

- 3a. Some participants might not have space on their phone to download another app. If this happens, ask them if they are okay with deleting any of the apps on their phone, such as apps for news or games, to make space for the Fitbit app. Delete the suggested apps.
- 3b. For iPhones, you might need to help the participant find/remember their Apple ID and password to download the app from the App Store (if they did not bring the information with them).
 - If a participant does not remember their Apple ID password, you can reset it:
 - i. Open the Settings app
 - ii. Select their "[name]"
 - iii. Select "Sign-In & Security"



- iv. Select "Change Password"
- v. If participants have a numeric passcode on their phone, they will be asked to enter it
- vi. Enter the new password and verify it
 - The password must have at least 8 characters, include a number, an uppercase letter, and a lowercase letter
- vii. Select "Change"
- 4. Change the phone Settings so that the Fitbit app will update automatically when changes are made.
 - Android
 - i. Open the Google Play Store app
 - ii. At the top right, tap the profile icon
 - iii. Select "Manage apps & device"
 - iv. Select "Manage", then find the Fitbit app
 - v. Tap on the Fitbit app
 - vi. On the page with details about the Fitbit app, in the upper right-hand corner tap the "More" icon
 - vii. Turn on "Enable auto update"
 - iPhone
 - i. Open the Settings app on the phone
 - ii. Scroll down until you see the App Store, tap the "App Store"
 - iii. Turn on "App Updates: Automatically Install New App Updates"
- 5. Make sure the phone Settings allow for use of the Fitbit app on cellular data.
 - Android
 - i. Open the Settings app on the phone
 - ii. Tap "Connections"
 - iii. Tap "Data usage"
 - iv. Tap "Network access"
 - v. In the list of apps, make sure both Mobile Data and Wi-Fi are checked for the Fitbit app
 - iPhone
 - i. Open the Settings app on the phone
 - ii. In the search bar (at the top of the screen), type in "Fitbit"
 - iii. Select "Fitbit"
 - iv. Make sure "Cellular Data" is toggled on for the Fitbit app
- 6. Drag the Fitbit app onto the first "page" of the phone's home screen in a visible place. Show the participant where the app is located.

- 7. If the participant owns their own Fitbit, but they opted to use the Fitbit Charge 6 for the study, remove their other Fitbit Watch from the Settings app on their smartphone
 - Android
 - i. Open the Settings app on the phone
 - ii. Select "Connect devices" or "Device connection"
 - iii. Tap the "gear" icon beside whatever other Fitbit Watch is present
 - iv. Select "Forget"
 - Select "Forget Device" if another menu is displayed
 - iPhone
 - i. Open the Settings app on the phone
 - i. Select "Bluetooth"
 - ii. Select whatever other Fitbit Watch is present
 - iii. Select "Forget This Device"

Setting Up a Fitbit Account

- 1. Open the Fitbit app
 - A message will pop up on the phone: "Fitbit Would Like to Use Bluetooth: The Fitbit app needs to sync with your device to store your steps, sleep or weight."
 - o Select "OK"
- 2. Select "Sign in with Google"
- 3. Select "Add an account"
- 4. A message will pop up on the phone: "Fitbit Wants to Use google.com to Sign In: This allows the app and website to share information about you."
 - o Select "Continue"
- 5. Select "Create account" on the lower left-hand sideo Select "For my personal use"
- 6. Enter the participant's first name (do not enter the participant's last name)
- 7. Enter the following for the participant's birthday:
 - o Month: January
 - o Day: 01
 - Year: [year the participant was born]
- 8. Enter the participant's gender, selecting from the following:
 - Female, Male, Rather not say, Custom
 - o Select "Next"



- 9. Select "Create your own Gmail address"
 - You can use letters, numbers and periods
 - <u>Each participant (regardless of whether they already have a Gmail address),</u> will have an ARIC study Gmail address created for them for the Fitbit study.
 - Minneapolis site: aricstudy.m.###@gmail.com
 - Jackson site: aricstudy.j.###@gmail.com
 - Forsyth County site: aricstudy.f.###@gmail.com
 - Washington County site: aricstudy.w.###@gmail.com
 - Create an ARIC study Gmail address for each participant, replacing "###" in the email address with "001" for the first enrolled participant. Continue this for the second participant ("002"), and so on and so forth.
- 10. Create a strong password with a mix of letters, numbers, and symbols
 - The participant can create their own password
 - Write the participant's Gmail address and password down for them on the StartKit
 - Enter the participant's Gmail address and password into the FBI form
- 11. A message will pop up asking if you would like to save this password to your iCloud Keychain to use across apps and websites on all your devices, select "Not Now"
 - This message will only pop-up for iPhone users
- 12. Confirm you're not a robot via a text verification code sent to the participant's phone. Enter their mobile phone number, then select "Next"
 - Enter the 6-digit verification code to confirm you received the text message, then select "Next"
- 13. When asked to add a recovery email, select "Skip"
- 14. When asked to add a phone number, scroll to the bottom and select "Skip" on the left-hand side
- 15. On the screen, "Review your account info"o Select "Next"
- 16. On the screen, "Privacy and Terms"O Scroll to the bottom and select "I agree"
- 17. A message will pop up: "Confirm personalization?"
 - Select "More Options"
 - Under Web & App Activity, select:
 - "Don't save my Web & App Activity in my Google Account"
 - "Show me ads that aren't personalized"
 - "Don't save my YouTube History in my Google Account"
 - o Select "I agree"



- 18. On the screen, "Looks like you're new to Fitbit"
 - o Select "Continue as new user"
- 19. On the screen, "Understand your privacy on Fitbit"
 - Scroll to the bottom and consent to the two conditions by checking off the two bubbles next to the statements
 - o Select "Agree and continue"
- 20. Enter the participants weight (lbs.), height (ft. and in.), and sex (female or male). Participant's height from records, weight from their current visit, and sex will be self-reported.
 - Select "Save & continue"
- 21. On the screen, "Fitbit is ready to use"
 - Select "Continue"
- 22. On the screen, "Help build new products and advance health research"
 - Select "No thanks"
- 23. On the screen, "Email and notification preferences"
 - o Under Email notifications, turn off "News and Updates" and "Research Invites"
 - o Under Push notifications, turn off "Research Invites"
 - o Select "Save and continue"

You can use this web browser method if you are getting an error message when trying to setup the participant's Gmail/Fitbit account on their phone.

- Complete steps 5-17 listed above (some of the steps you won't be asked to complete as they are specific to creating an account on a phone)
- After Step 17 is complete, open up the Fitbit app on the participant's smartphone
- o Select "Sign in with Google"
- Select "Add an account"
- Sign in with the newly created Gmail address and password
- Select "Continue as [participant's name]"
- Continue with steps 18-23 listed above

Pairing Fitbit Watch to the Phone

- 1. On the screen, "What would you like to do?"
 - o Select "Add device"

- On the screen, "What are you setting up?"
 Select "Charge 6"
- 3. Select "Set Up""
- 4. Scroll to the bottom of the page and select "I Agree" to connect the Charge 6 to the Fitbit app
- 5. On the screen, "Let it charge"o Select "Next"
- 6. The phone will search for the Fitbit Charge 6 (make sure the Watch is plugged in to charge, as this is

required to "find" the watch regardless of its battery percentage)

- Once the Phone "finds" the Watch, a 4-digit code will appear on the Watch
 Enter the 4-digit code into the phone
- 8. A message will pop up on the phone: "Bluetooth Pairing Request: Charge 6 would like to pair with your phone"
 - o Select "Pair"
- 9. A message will pop up on the phone: "Allow Charge 6 to Receive Your Notifications: When connected, all notifications you receive on your phone will also be sent to the Charge 6 and may be shown on its display"
 - Select "Allow"
- 10. Select "Not Now" when asked about Protecting Your New Device
- 11. On the screen, "Set up irregular rhythm notifications"
 - o Select "Skip"
 - DO NOT enable this for participants
- 12. Demonstrate to the participant how to charge the Watch, how to wear the Watch correctly, and provide them with a Loop band (to replace the original band)
 - o Select "Next"
 - Remove the old band and put on the new one
 - If the participant has a spouse also being enrolled in the Fitbit study, try to provide them with different colored wrist bands
 - If the participant is choosing to wear the Fitbit on their non-dominant wrist long-term, and they are also choosing to use the Leap and WatchPat devices, make sure the band is long enough for the Fitbit to be placed a bit further up the arm when wearing all three devices simultaneously.





- 13. On the screen, "Allow Fitbit to Use Your Location?"o Select "Don't Allow"
- 14. On the screen, "Press button to wake" o Select "Next"
- 15. On the screen, "Swipe to navigate"Select "Next"
- 16. On the screen, "Swipe to go back"o Select "Next"
- 17. On the screen, "Tap 3x to zoom in"
 - Select "Next"
 - You can turn on Magnify in device settings at a later point if the participant wants the feature
- 18. On the screen, "Wear & care tips"Select "Next"
- 19. On the screen, "All Set!"
 - o Select "Done"
- 20. Option to buy Premium will come up on the phone
 - o "X" out, we are not setting up Premium memberships for the participants

Fitbit Charge 6 – Set up for Participant Use

This section describes how to prepare the Fitbit Charge 6 for participant use, focusing on app and Watch features related to physical activity, heart rate, and sleep.

Tailoring the Fitbit App – Device Settings

- 1. Go to the "Device Settings" by selecting the icon in the upper left corner
- 2. Select "Charge 6"

2a. Select "Wrist"

 Select either "Dominant" or "Non-Dominant" by asking the participant whether the watch is on their dominant or nondominant arm. Place the watch on whatever wrist the participant wants to wear it on <u>long-term</u>, to minimize switching during the study.



2b. Select "Notifications"

- i. Ask the participant if they want to receive notifications on their Watch for calls, text messages, and calendar events. Toggle "off" if they do not want them.
- 3. Select "Add phone" (**SKIP this step and go directly to step 4, if** participants share a smartphone; i.e., a spouse pair shares a phone and you are creating a Fitbit account for both of them on the same phone/app)
 - i. You are adding their phone as a device to the Fitbit app, so that if they take off the Fitbit Watch for a bit, but they are carrying their phone, their steps will still be collected.
 - 3a. On the screen, "Take charge of your health right from your phone"
 - i. Select "Continue"
 - 3b. On the screen, "Use your phone to track metrics with Fitbit"
 - i. Select "I agree"
 - ii. For Androids, a box will pop up asking "Allow Fitbit to access your physical activity?"
 - a. Select "Allow"
 - 3c. **For iPhones**, on the screen, "Connect Fitbit to Apple Health to track steps"
 - i. Select "Continue"
 - 3d. **For iPhones**, on the screen, Health: "Fitbit" would like to access and update your Health data
 - i. Toggle/Turn on Stepsii. Select "Allow" in the upper right-hand corner
 - 3e. For Androids, on the screen, "Get more from your data with Health Connect"
 - i. Select "Not now" in the bottom right-hand corner
 - 3f. On the screen, "You're ready to go"
 - i. Select "Done"



- 3g. Option to buy Premium will come up on the phone
 - i. "X" out, we are not setting up Premium memberships for the participants
- 3h. On the screen, "Connected to Fitbit", you should now see that both their Charge 6 and Phone are connected as devices
- 4. Go back to the "Today" screen
- 5. Go to the "Account Settings" by selecting the icon in the upper right corner
- 6. Select "Fitbit Settings"

5a. Select "Activity & Wellness"

- i. Select "Daily Activity"
 - Change the daily Steps goal to 4,500
 - According to Visit 6 ARIC data, older adults that



walked ~4,500 steps per day had a 77% lower observed risk of experiencing a cardiovascular event.

- Change the daily distance goal to 2 miles
 - There are about 2,100 steps in a mile
- o Daily steps and distance goals can also be adjusted later per participant preference
- ii. Select "Sleep"
 - Change "Sleep Sensitivity" to "Sensitive"
 - You may not be able to change the sleep sensitivity for Android devices here, an alternative method is provided in the next step (Step 5b).
- 5b. For Android devices only: Select "App Settings"
 - i. Change "Sleep Sensitivity" to "Sensitive"

Tailoring the Fitbit App – Today Screen

There are 3 tabs along the bottom of the app screen (Today, Coach, and You). <u>Participant use</u> will be focused on the Today screen.

- 1. Go to the Today screen by selecting the "Today" icon 🛛 🛓 in the bottom left corner
- 2. Choose the Spotlight Stats for the Today screen
 - 2a. Select the "pencil" in the upper right corner
 - 2b. Under "Choose Focus", swipe to the left until you see the focus "Custom preset", select the "pencil" in the upper left corner of "Custom preset"
 - 2c. Update the four metrics to: Steps, Distance, Sleep duration, and Hourly activity
 - 2d. Select "Save," in the upper right corner of the Edit Focus screen
 - Steps, Distance, Sleep Duration, and Hourly Activity will now be emphasized on the Today Screen
- 3. Remove certain features from the Today Screen to simplify the interface and keep the focus on the study outcomes (physical activity, heart rate, and sleep)

3a. Under Hide/Show metrics

- i. Turn On/Show: Sleep Duration, Exercise, Active Zone Minutes, Steps, Hourly Activity, Distance, Energy Burned, Health Metrics, and Heart
- ii. Turn Off/Hide: Menstrual Health, Weight, Glucose, Mindful Days, Stress Management Score, Food, and Water
 - Some of these features can be kept if the participant wants them. However, make sure to tell the participant that they would be tracking these metrics manually for their own interest. It's not a requirement of the study.
- 3b. Select "Save," in the upper right corner

At this point, you should educate the participant on how to use the Fitbit smartphone app and Watch. Focus the education on how to monitor physical activity, sleep, and heart rate. You can use the participant's educational packet (StartKit) as well as the Fitbit App and Watch Education Checklist and Example Script to guide this education. You should pull up the Fitbit app on your own smartphone to educate the participant on how the app looks once real data starts coming through. After educating the participant on the app and Watch, return to this MOP and continue with the subsequent sections.

Tailoring the Fitbit App and Watch – Additional Customizations

- 1. Changing Text Size in the Fitbit App
 - Ask the participant if they would like you to enlarge the font size in the Fitbit app
 - You can skip this step if they are happy with the current font size

1a. iPhone

- i. Open the Settings app
- ii. Select "Display & Brightness"
- iii. Select "Text Size"
- iv. Drag the slider to select the desired font size
- v. Confirm the new text size in the app is appropriate for the participant

- 1b. Android (11 and Older)
 - i. Open the Settings app
 - ii. Select "Display"
 - iii. Select the option "Font Size" (may be called "Font and Screen Zoom" in some phones)
 - iv. Depending on the phone: drag the slider to select the desired font size OR select from small, medium, or large fonts
 - v. Confirm the new text size in the app is appropriate for the participant
- 2. Enabling the Magnify Feature on the Fitbit Charge 6
 - Ask the participant if they would like you to enable a feature that allows them to magnify the font size on the Watch
 - You can skip this step if they are happy with the current font size or don't like the magnify feature
 - 2a. Scroll down on the Fitbit Charge 6 Watch screen until you see "Settings"
 - 2b. Select "Settings"
 - 2c. Scroll up until you see "Magnify Settings"
 - 2d. Select "Magnify Settings"
 - 2e. Make sure the feature is turned/toggled on
- 3. Enabling Sleep Mode on the Fitbit Charge 6
 - Ask the participant if they would like you to enable a feature that will stop them from receiving notifications on the Watch while they sleep as well as make sure the Watch doesn't light up at night while they are sleeping
 - You can skip this step if they don't need this feature
 - 3a. Scroll down on the Fitbit Charge 6 Watch screen until you see "Settings"



- 3b. Select "Settings"
- 3c. Select "Quiet Modes"
- 3d. Scroll down and select "Sleep Mode"

3e. Select/Turn on "Schedule"

- 3f. Select "Interval"
- 3g. Set the times for roughly when they go to bed and wake up every day so they do not receive notifications on the Watch or have the Watch light up during this time
- 4. Enabling Water Lock on the Fitbit Charge 6
 - Ask the participant if they swim regularly as a form of physical activity. If yes, demonstrate to them how to enable/disable the Water Lock feature when they are swimming.
 - There is no setup required for using this feature, you just need to demonstrate to the participant how to use the Water Lock feature every time they want to go swimming.
 - You can skip this step if they don't need this feature

The participant should complete steps 4a-4b before going swimming:

- 4a. Scroll down on the Fitbit Charge 6 Watch screen until you see "Water Lock: Turn on"
- 4b. Select "Water Lock: Turn on"
- 4c. When you see "To lock: Firmly double tap", double tap on the Watch screen <u>very forcefully</u>
- 4d. You will get a message that the Watch is locked

The participant should complete steps 4e-4f after going swimming:

- 4e. After swimming session is complete, make sure the Watch is dried off completely
- 4f. To disable the Water Lock feature, double tap on the Watch screen very forcefully

Downloading the Gmail App

- 1. Download the Gmail mobile app onto the participant's smartphone. For iPhones, download the app from the iOS store. For Android phones, download the app from Google Play.
 - Some participants, especially if they own an Android, may already have the Gmail mobile app already installed on their phone. If this is the case, you will just need to add another email account to the app.
- 2. Drag the Gmail app onto the first "page" of the phone's home screen in a visible place next to the Fitbit app. Show the participant where the app is located.



- 3. Open the app, then select "Sign in"
- 4. Under "Set up Email", select "Google"
- 5. A message will pop-up: "Gmail Wants to Use google.com to Sign In", select "Continue"
- 6. Enter in the participant's Google Email, then select "Next"
- 7. Enter in the participant's Gmail password, then select "Next"
- 8. On the screen "Google 2-Step Verification", select "Try another way"
- 9. Select "Get a verification code at (***) *** **XX"
 - Make sure that is the participant's phone number
- 10. Enter the 6-digit verification code, then select "Next"
- 11. A message will pop-up: "Google would like to Send You Notifications", select "Allow"
- 12. The participant can now open the Gmail app to see their weekly feedback emails from Fitbit

4. On the Manually Connect Device screen, **enter the Fitabase participant ID** (instead of First Name), and **Gmail address** used to sign in with Fitbit. The Fitabase participant ID will be populated in the FBI form. This is a masked version of the ARIC ID that changes the letter to a number (F=1, J=2, M=3, W=4) and reverses the numeric portion of the ID. With both CDART and Fitabase open on the computer, enter this identifier in Fitabase by copying this field from CDART (ctrl + c) and pasting (ctrl + v) into Fitabase. This method is highly preferred over manual entry in order to avoid transcription error.

- 2. Find the participant in Fitabase and check when their last sync was. This information will be used in the scheduled phone call.
- 3. Document the phone call in the Fitbit Support Log (FBT).

If participants are having significant problems that can't be answered by staff over the phone, the field center staff will ask the JHU wearable team to call the participant to troubleshoot. If the JHU wearable team is unable to resolve the problem, they will let the field center staff know that a home-visit is required. In that case, the staff member should bring a replacement Fitbit device on the home-visit in case the problem can't be fixed.

As Needed Touch-Points

- A text message will be sent directly to each participant's phone, if they agreed to receive text messages, if they haven't synced in the past 5 days. This text message will thank them for their continued involvement in the study, remind them to sync, and refer them to the StartKit if they need a reminder on how to sync.
- Participants may call the field center with questions about the Fitbit. Staff should attempt to answer these questions. It is helpful to have the Fitbit app open on your personal smartphone when trying to answer participant questions / guide them to the correct feature. However, if the staff are unable to answer the question or solve an issue that a participant is having then the JHU wearable team will be asked to call the participant to resolve the issue. Either the staff or the JHU Wearable team can also send the participant a Zoom link via text message or



email to facilitate troubleshooting. These contacts with the participant will be documented in the Fitbit Support Log (FBT) by the field center staff.

- Staff will review Fitabase at least 2-3 times a week, for participants at their field center who have not synced / provided Fitbit data in the past 2 weeks.
 - In Fitabase, navigate to the Participants page by using the dashboard menu link
 - Filter by last sync, so that participants who have gone the longest without syncing are at the top of the participant list
 - Call the participants that day who have not synced in the past 14 days
 - Use the "Telephone Script for Fitbit Nonadherence" to guide the conversation
 - Document the call in the Fitbit Support Log (FBT)

Fitbit Satisfaction Follow-Up

Three to six months following Fitbit Study enrollment, clinic staff will call the participant to complete the Fitbit Satisfaction Questionnaire (FSQ). The purpose of this form is to assess the participant's overall satisfaction with their experience wearing the Fitbit device, whether they are currently enrolled in the study or have previously withdrawn. While 3-6 months after enrollment is the standard time period to collect this form, any time after the 3-month mark is permissible.

Fitbit Satisfaction Scheduling Report

The Fitbit Satisfaction Scheduling Report is available in CDART to support data collection of the Fitbit Satisfaction Questionnaire. The Fitbit Satisfaction Scheduling Report displays participant enrollment dates, FSQ eligibility, and contact information. This report can be run through the CDART main menu and will be used by site staff to determine whether participants are eligible to have an FSQ form collected.

Fitbit Follow-Up and Implanted Medical Device Alerts

During annual and semi-annual follow-up calls, staff will complete the Fitbit Check-in (FCN) form to assess whether a participant wearing a Fitbit has received a pacemaker since the previous contact point. If a participant is known to be wearing an ARIC Fitbit, the Annual Participant Tracing Sheet will indicate that the FCN form should be collected. Like the Medical Conditions Update form (MCU), the same occurrence of the FCN should be updated during each check-in call until the Tracing sheet indicates that the FCN form no longer should be collected or the participant indicates that they have received a pacemaker.

A "Yes" response to question 1 of the FCN form indicates the participant has received a pacemaker or cardiac defibrillator since the last follow-up call and will trigger an alert in the Visit 11 Alerts Report on CDART. To resolve this alert, clinic staff will send the Implanted Medical Device Letter for Fitbit to the participant to request the return of their Fitbit device. This letter can be found and downloaded from the ARIC website under **Researchers > Supporting Documents > Visit 11/NCS**. Staff should download the template, fill in the participant's information where appropriate, then print and send the letter to the participant. Once this letter has been sent, the alert should be recorded and resolved using the RARX form within the usual alerts reporting time frame. Only one alert will ever be triggered for Fitbit, and once the alert has been resolved, no additional action is needed by clinic or follow-up staff.

Fitbit Results/Notification Questions

If participants call with questions about their Fitbit results, do not provide any clinical advice about what these data mean. You can direct participants to these results in Fitbit if they are having trouble finding them or you can reiterate interpretation that is already provided in Fitbit. For example, if a participant were to tell you they received a sleep score of 80 the night before, you could tell them Fitbit interprets this as a "Good" sleep score. Document the phone call in the Fitbit Support Log (FBT).

If participants call with inquiries about low or high heart rate notifications from Fitbit, refer to the script "Telephone Script for Fitbit Heart Rate Inquiries" on how to respond. Document the phone call in the Fitbit Support Log (FBT).

Fitbit Replacement

Participants can receive up to 5 replacement Fitbit Watches throughout their enrollment in the study due to loss of, damage to, malfunction of, or battery loss of the original device (or prior replacement). Participants are eligible to receive a replacement Fitbit Watch if they (1) wore the previous Watch for more than half the time they had it (e.g., at least 3 out of 6 months), or (2) they didn't wear the previous Watch for more than half the future. Staff discretion can be used when deciding who is eligible to receive a replacement Fitbit. There should be no evidence that the participant gave their Fitbit Watch to someone else. Participants are not allowed to gift their Fitbit to someone else and then ask for a replacement. In instances when the Watch was damaged, malfunctioned, or the battery died, participants will be asked to return the device when receiving a new one. Fitbit replacement (including Watch, charger, and band if needed) can occur at the field center or via a home visit, depending on participant preference. If the participant just needs a new charger or Watch band, they can pick it up at the field center or it can be mailed to the participant's home, depending on their preference. All Fitbit Watch replacemente in the Fitbit Initialization Form (FBI) in Section D.

To link a new Fitbit to the participant's Fitbit app, first, remove the current Fitbit Watch from the participant's Fitbit app:

- 1. Open the participant's Fitbit app on their phone.
- 2. On the Today screen, tap the device icon in the upper left-hand corner.
- 3. Select "Charge 6".
- 4. Scroll down and select "Remove This Charge 6".
- 5. A reminder will pop up to sync the Watch one last time, select "Remove This Charge 6".a. If the Watch is broken you most likely won't be able to complete the syncing process.

Fitbit Setup with New Phone

If a participant buys a new phone over the course of the study, a staff member can help them resetup their Fitbit with the new device. Set-up can be conducted either at the field center or via a home visit, depending on participant preference. Set-up will include repeat of the following aspects in Section 2.4 of this Manual: "Fitbit Charge 6 – Install and Create an Account", "Pairing Fitbit Watch to the Phone", "Fitbit Charge 6 – Set up for Participant use", and "Downloading the Gmail App". No changes need to be made within Fitabase; however, once the set-up is complete, sync the Watch to the Fitbit app and make sure the most recent sync shows up in Fitabase.

• Make sure to use the participant's original study related Gmail address when resetting up the Fitbit app.

Fitbit Return/Recycle

If a participant decides to return their Fitbit Watch and disengage from the study, this should be recorded in Section D of the FBI form. The Fitbit can then be recycled for another participant using the following steps:

1. Sync the Watch to the participant's Fitbit smartphone app one last time to make sure their most recent data is captured in Fitabase. Check their data in Fitabase to make sure it synced properly.

a. If the participant returns the Watch by mail, you will be unable to complete this step. However, in the StartKit, participants are reminded to sync one last time before mailing the Watch back.

- k. Select "Logout" in the upper right-hand corner
- 7. The Fitbit Watch can now be given to another participant.

3 DATA AND RESULTS TRANSFER

3.1 DATA DOWNLOAD / RESULTS TRANSFER

Bi-monthly (every 60 days) summary data on Fitbit adherence will be generated by the Johns Hopkins Wearable Team through Fitabase and will be sent to the Coordinating Center. These adherence reports will include data on Fitbit wear time and syncing. All other data (e.g., sleep, activity, heart rate) will be stored in Fitabase and not CDART.

Participants' result reporting will occur directly from Fitbit (data on the Fitbit app as well as weekly summary emails to the participant). No results reporting to the participant will come from CDART.

4 TRAINING AND CERTIFICATION

Prior to conducting the Fitbit protocol at ARIC Visit 11, <u>all current examiners are to be certified</u> <u>by completing the following:</u>

- Attending the in-person Fitbit training delivered by Dr. Spaulding in January 2024 at the local field center, prior to the study start date.
- Review Manual 49 which details the Fitbit protocol, and the participant StartKit.
- Watch a mock visit* conducted by Dr. Spaulding at the in-person training session in January 2024.
- Complete a mock visit* or visit** as overseen by Dr. Spaulding at the in-person training session in January 2024. Each staff member to be certified will complete a mock run through of the procedures.

For new staff hired after the initial in-person training session conducted by Dr. Spaulding, certification procedures will include:

- Review Manual 49 which details the Fitbit protocol, the participant StartKit, and the Fitbit App and Watch Education Guides.
- Watch a visit** conducted by a previously certified examiner.
- Complete a visit** as overseen by a previously certified examiner. Each staff member to be certified will complete a run through of the procedures.

* The mock visit will include completing Section 2.4 of this Manual with a staff member acting as the participant. The Fitbit Onboarding Checklist, **found in Appendix 5.1**, will be used to evaluate and provide feedback on a staff member's performance of the core competencies. Dr. Spaulding or a previously certified examiner can decide whether the staff member needs to be overseen in more than one visit prior to certification.

** The visit will include completing Section 2.4 of this Manual with a pilot volunteer participant or an ARIC participant. The Fitbit Onboarding Checklist, **found in Appendix 5.1**, will be used to evaluate and provide feedback on a staff member's performance of the core competencies. Dr. Spaulding or a previously certified examiner can decide whether the staff member needs to be overseen in more than one visit prior to certification.
